TUACAHN 2011 SATURDAY MARKET

Vendor Agreement/Contract

Vendor understands and agrees to the following:

1. Tuacahn's focus for the Market is on the arts, unique handcrafted gifts, home decor & seasonal Farmers Market of fresh produce. Some resale items are allowed, however all items sold must be pre-approved by Show Management.
2. A 10X10 Canopy/tent is mandatory and **must be white** (any other colored canopy can be covered inexpensively with white fabric). Please be prepared with **weights** for periodic windy conditions. Vendors are responsible for Insurance covering their own personal products and property.
3. Vendors are not permitted to sell any type of chances or conduct any type of "lottery" for his/her merchandise.
4. No smoking except in designated areas. Consumption or selling of alcoholic beverages is prohibited on Tuacahn property.
5. Vendors assume responsibility for all assistants, associates or helpers participating with the Vendors. At the discretion of Tuacahn Market Management, any behavior or conduct deemed unacceptable shall be grounds for removal of said Vendor from the Market.
6. You will receive direction to your booth space when you arrive and check in with Management each Saturday morning.
7. Set up will begin no sooner than 7:00 AM and be finished by 8:45 AM. It is mandatory that you keep your booth open for business until the closing of the show at 1:00 PM. Failure to comply with this rule will jeopardize future invitations to the Tuacahn Saturday Market. Total clean up must be within 2 hours of closing.
8. Vendors will be charged any cleaning or repair costs (grease on pavement, trash, destruction of site property etc) incurred.
9. During bad weather, Management may wait 20 minutes to consider possible changes in weather before 'calling' the show. To leave before the Show is officially 'called' will result in lost fees.
10. I understand that the prepayment funds for the Saturday (s) of my choice are non-refundable but may be credited to a future show within 24 hours notice.
11. Incomplete Applications will not be accepted. All signatures are mandatory. By signing this Contract, Vendor (s) acknowledges and agrees to all of the provisions hereof.
12. The discretion of the Tuacahn Saturday Market Representatives will prevail in all cases.
13. Payment must be received prior to the Saturday you exhibit.
14. Vendors must be in compliance with the Utah State Tax Commission Special Events Division. Vendors must file quarterly estimated tax earnings with the State of Utah. We do not issue Temporary Permits. We are required to let the Tax Commission know who has been here - which we do each month. It is your responsibility to contact them.
