- 5' X 10' Sidewalk Space – No Canopies allowed, but a limit of two umbrellas may be used for protection from the elements.

**IMPORTANT!** All display tables are required to be covered with a 'cloth' tablecloth which goes TO THE GROUND. Plastic tablecloths are not allowed.

I understand that the discretion of the Tuacahn Saturday Market representatives will prevail in all cases.
